FOOD (LABELLING)

The Labelling of Food (Amendment No. 2) Order, 1949

<i>Made</i> - - - - -	15th August, 1949
<i>Laid before Parliament</i>	15th August, 1949
<i>Coming into Operation</i>	20th August, 1949

In exercise of the powers conferred upon him by Regulation 2 of the Defence (Sale of Food) Regulations, 1943(a) as having effect by virtue of the Emergency Laws (Miscellaneous Provisions) Act, 1947(b), and of all other powers him enabling, the Minister of Food hereby makes the following Order:—

1. The Labelling of Food Order, 1946, as amended (c), shall be further amended as follows:—

- (a) by inserting in Article 6 thereof after the words “ in his possession for sale any canned ” the words “ or frozen ” ;
- (b) by inserting in the said Article 6 and sub-paragraph (b) thereof after the words “ otherwise processed prior to canning ” wherever they appear the words “ or freezing ” ;
- (c) by inserting in column 1 of item 8 in Table A of the First Schedule thereto, immediately before the item relating to curry powders, the item “ Christmas puddings ” ;
- (d) by deleting from Table C of the First Schedule thereto the item relating to Christmas puddings.

2. This Order shall come into operation on the 20th day of August, 1949, and may be cited as the Labelling of Food (Amendment No. 2) Order, 1949.

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

This amending Order—

- (a) imposes special requirements as to the labelling of frozen peas ; and
- (b) transfers Christmas puddings from Table C in the First Schedule to the principal Order to item 8 of Table A in that Schedule thereby providing that notwithstanding the revocation of the Manufactured and Pre-packed Foods (Control) Order, 1942, the ingredients of Christmas puddings need not be specified in accordance with Article 2 (3) of the principal Order.
